4. Treasurer's Report

4a. Review of December 31, 2018 Financial Statements

Karl Firor reviewed the Profit and Loss Report and noted an expense of \$140k for Jeffcom communication equipment. Karl noted there is a total of \$278k in the bank. This amount exceeds the amount anticipated of \$113k by \$164k. The Jeffcom expense was offset by grants and donations.

Karl reviewed the Balance Sheet noting a total of \$1,503,000 in the bank. Karl advised \$1,274,000 is in the Colorado Trust Account with the remainder in First Bank, keeping in line with FDIC requirements. Kerry inquired as to Jeffcom capital assets versus fixed assets. Karl confirmed for our internal accounting capital expenditures are treated as an expense and then reallocated by auditors per governmental accounting rules. Karl advised he will be receiving adjusting journal entries from the auditors once the 2018 Audit is complete.

MOTION: There was a motion by Mike Swenson with a second by Kerry Prielipp to approve the January 9, 2019 Treasurer's Report as presented. The Motion passed unanimously.

5. Chief's Report

Please see attached. Kelley Wood advised Chief Shirlaw, Deputy Chief Hatlestad and Capt Matt Araki are all in Colorado Springs attending Wildland Academy.

Statistics are attached and indicate total calls this year were just shy of last year, making 2018 the second highest year in call volume. There were mutual aid calls to structure fires in neighboring districts. Call response has still been good, the lower number for attendance may be due to differences in the ESO software.

Jennifer Volkman asked if anyone went to Day with the Chiefs. No one had been available. Jennifer indicated she did attend and stated it was impressive.
